

## Maintenance Program - Manual Retractable Bollard

Manual Bollards require maintenance at least once per year. This document outlines the maintenance that needs to be completed once per year. Pricing is per bollard, per visit.

Qty 1 bollard: \$350.00 per bollard, per visit

Qty 2 bollards: \$300.00 per bollard, per visit

Qty 3 or more bollards: \$250.00 per bollard, per visit

+ \$3.00/km per round trip

### Maintenance includes:

- Clean the drains for water discharge on the floor of the foundation box
- Vacuum out any dust or debris that has built up
- Lubricate the bollard
- Check and clean the internal guides
- Tighten any loose screws or hardware
- General cleaning of bollard and bollard pit



## **Residential Bollard Warranty**

**Ontario Bollards Inc. warrants the bollards to be free from defects in workmanship for 12 months effective from date of supply. And will repair or replace at its option any product which it determines to be defective.**

**Our warranty does not extend to “fair wear” and “tear” or negligent use of our product. Warranty will be void should it be determined that the scheduled maintenance outlined in the user manual has not been followed.**

**This warranty is in lieu of all other warranties expressed or implied. Ontario Bollards Inc. shall not be liable for any special indirect, incidental, or consequent damages of any kind or nature.**

**The Purchaser acknowledges and agrees with Ontario Bollards Inc. that it is satisfied that the goods are suitable for its intended purpose, and in no way implies that the bollards supplied or installed will guarantee to protect their vehicle from theft. Residential bollards are a visual and physical deterrent only and cannot guarantee against theft of property.**

**That in all matters relating to the goods along with placement of the bollards, the Purchaser has relied and will rely entirely upon the purchaser’s own judgment.**

**Bollards must be serviced a minimum of one time per year, by Ontario Bollards or an approved sub-contractor in order for warranty to remain valid.**

**Delivery and or installation shall be conclusive evidence that the goods accord in any respect with the Purchaser’s requirements and are in good condition and complete in all respects.**

**That any implied warranty or condition, whether Statutory or otherwise, and whether as to the quality, state, condition, or fitness for any particular purpose or as to any other matter or thing whatsoever is hereby expressly excluded from this contract.**
